



## **Pheasant View Farm Cross-Country Schooling Show**

**Saturday July 21, 2018**

Opening Date: June 26, 2018 Closing Date: Received/Postmarked by July 14, 2018

**This is a Fund Raiser for Pheasant View Farm's CSDEA Facility Development Matching Grant, which supports our new water complex! All entry fees count towards the matching grant.**

**General:** This is meant to be a practice at riding a complete course without the pressure of being a recognized show. First round should be ridden without assistance, second round riders may be coached if desired. The point is to enjoy yourself in this sport!

**Entries:** **First Round** - \$ 50 per entry, \$40 for Central States Members (join or renew at [www.csdea.org](http://www.csdea.org))

**Second Round** – Optional, non-scored - \$30 for everyone. Second Rounds may be entered the day of the show. Maximum of two rounds per rider/horse pair. Second round at higher level may be attempted if safety permits.

**If time permits, schooling for non-competes may be allowed with your trainer at \$ 30 per rider/horse combination if time allows after the show closes. Check-in/out, helmets, Coggins, and releases required.**

Entries may be limited to the first 50-60 horses. **Since this is a Fundraiser, unless the show is cancelled and not rescheduled for bad weather, there are no refunds after closing date unless your spot can be filled**

### **A complete Entry includes:**

- 1) Completed Entry Form.
- 2) Signed CSDEA Release.
- 3) Signed Pheasant View Farm Release.
- 4) Copy of current negative 2018 Coggins.
- 5) **Check to CSDEA for entry fees.**

6) **Make a separate check made to "Ginger Cantor"** for requested stabling if available. Check will be held separately. In the event we cannot honor the request, it will be returned.

**Stabling:** Funds must be received in advance to reserve, call to inquire about availability. Assigned on first reserved basis; if same entry postmark, those traveling from farthest away receive preference.

- Limited day stabling (\$20)
- One day/overnight paddock with shelter and water (\$50 – only for compatible horses)
- Call for overnight stalls (very limited)

**Attire:** All competitors **MUST** wear an approved and fastened ASTM/SEI helmet and footwear with heels when mounted. Cross country safety vests and medical armbands strongly recommended.

**Food:** Plan to bring your own food, but light refreshments may be available for purchase at the show.

**Facilities:** Portable Toilet provided; hoses available for horse rinsing, dip tank.

**Weather:** The show will be held in all weather, unless lightning.

**Trailing:** Please trailer with a buddy if possible. Trailer parking area is west end of farm, dip troughs will be provided.

**Times:** Ride times will be e-mailed to all competitors 48 hours before the show. Please include a legible e-mail address.

**Arenas:** Warmup: inside 180\*80 sand arena.

**Awards:** Prizes for first place. Ribbons 1<sup>st</sup> through 6<sup>th</sup> place.

Divisions: Divisions will run at distance and pace similar to a recognized Horse Trial. Maps provided in rider pack at the show. Course consists of flat areas and rolling hills. Beginner novice and novice courses include banks, ditches and water.

- 1) 17 years and under, Starter, XC fences are 12"-2'3", 8-12 jumps
- 2) 18 years and up, Starter, XC fences are 12"-2'3", 8-12 jumps
- 3) 17 years and under, Beginner Novice, XC fences max 2'7", 14-16 jumps
- 4) 18 years and up, Beginner Novice, XC fences max 2'7", 14-16 jumps
- 5) 17 years and under, Novice, XC fences max 2'11", 16-18 jumps
- 6) 18 years and up, Novice, XC fences max 2'11", 16-18 jumps
