- I shall indemnify and agree to pay any losses, damages, or costs incurred by NRF as a result of any damages or HARM caused to a third party by me, my spouse or children, my invited guests, my contractors or employees or by any equine I bring to the North Run Farm Schooling Show.
- I represent that I have the requisite knowledge, experience, training, coaching and ability to safely compete in this North Run Schooling Show.
